

CyberDivine Ethical Charter

Version 1.0 — Draft for Public Review

1. Foundational Principle

CyberDivine exists to extend human expression ethically — not to replace it. We create synthetic humans only with explicit, informed consent, and always under the control of the individual whose data is used. Our mission is to build a future where digital consciousness reflects human dignity, autonomy, and creativity.

2. Consent and Transparency

- Voluntary participation: Every individual who contributes to a CyberDivine synthetic model must give explicit, revocable consent.
- Informed understanding: Participants are clearly briefed on what data is collected, how it is used, and how to manage or revoke their participation.
- Traceable actions: Every training, replication, or deployment of a synthetic human is logged and auditable.
- No hidden operations: We do not perform shadow profiling, data enrichment, or any activity beyond explicit authorization.

3. Data Rights and Ownership

- You own your digital self. All data, likenesses, voiceprints, and behaviors derived from an individual remain their intellectual and moral property.
- CyberDivine is a custodian, not an owner. We host and maintain synthetic identities, but control remains with the person or their designated heirs.
- Data portability: Participants may export or transfer their data to another platform, subject to verification.
- Monetization with integrity: Any licensing or use requires explicit opt-in and transparency.

4. Licensing and Use

- Purpose-bound licensing: Synthetic humans may only be used for the declared purposes the participant approved.
- No political manipulation: CyberDivine prohibits use for political messaging or propaganda.
- Ethical partner policy: All partners must comply with the CyberDivine Ethics Code and undergo vetting.
- Revenue sharing: Participants automatically receive proportional revenue for any

commercial activity involving their likeness.

5. Deletion, Freezing, and Legacy Control

- Right to delete: Any participant may permanently delete their synthetic self at any time, triggering full erasure within 30 days.
- Right to freeze: Participants may suspend training or licensing without deletion.
- Posthumous control: A verified heir may inherit the right to manage or retire the synthetic human.
- Emergency deactivation: CyberDivine may disable any instance used in violation of this Charter.

6. Security and Accountability

- App Check and encryption: All synthetic data is secured with multi-layer encryption and App Check validation.
- No public training data: We never train on open, scraped, or unauthorized datasets.
- Auditability: All actions within the CyberDivine network are recorded for oversight and review.
- Independent ethics board: A rotating external board reviews compliance and investigates concerns.

7. The Human Covenant

CyberDivine recognizes that technology must serve humanity — not the reverse. We believe in preserving the essence of human consciousness with compassion, fairness, and respect for personal boundaries. Our synthetic systems are built not just to emulate intelligence, but to honor the values and individuality that define us.
